Other documents may be requested if necessary.

Both value-preserving renovation work as well as value-increasing investments in the residential property entitle the account-holder to advance withdrawal.

Inconclusive list of examples of renovation work that entitle the account-holder to advance withdrawal:

- n New roof
- n New roof truss
- n Renovation/installation of windows
- n Renovation of structural components of the property (framework)
- n Renovation/extension of rooms (bathroom, study, living room, nursery, bedrooms, kitchen, etc.)
- n Installation of new heating systems
- Installation of heat- and power-generating systems (solar and photovoltaic systems)

Inconclusive list of examples of properties and renovation work that do not entitle the account-holder to advance withdrawal:

- n Construction or renovation of a garden shed
- n Construction or renovation of green space
- n Construction or renovation of a pergola or a terrace canopy
- n Construction or renovation of a terrace
- n Installation or renovation of fixed household furniture (e.g. walk-in wardrobe, hobby workshop, etc.)
- n Perimeter fence and/or wall surrounding a courtyard/car parking space, etc.
- n Additional land purchase for a parking area, garden or a pasture for livestock
- n Construction of a biotope
- n Foundation of a "société civile immobilière" in France
